## **B5 a. HEALTH SERVICES**

Until the 1960's, health care was essentially offered by the Catholic Church and the state only cared for the destitute. More than 50% of Quebec residents could not afford the cost of doctors' fees and hospitalization. The **Quiet Revolution** inspired by the **welfare state\*** idea aimed at reducing inequality of access to, for instance, education and health services.




From 1960's onwards, the government began to pass a series of laws to improve health services. In 1970 the **Health Insurance Plan** was introduced offering health care free of charge to all Quebec residents.

\* Note: In a welfare state the government protects the health and well-being of all its citizens. (Oxford Canadian Dictionary)


